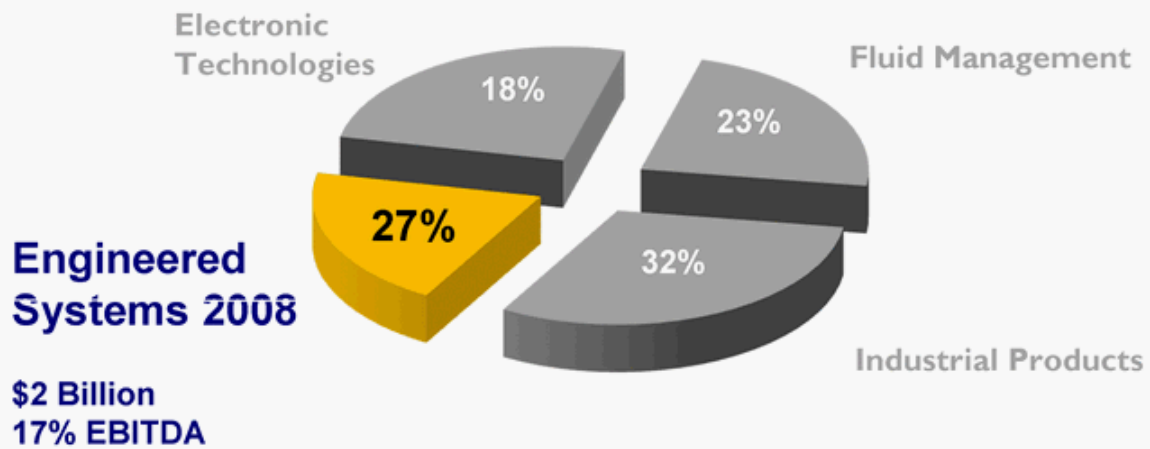

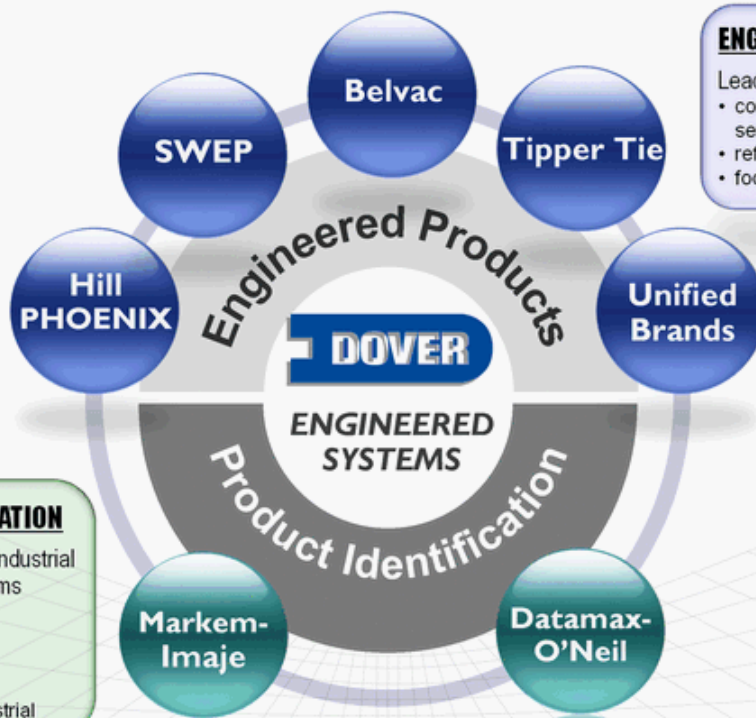

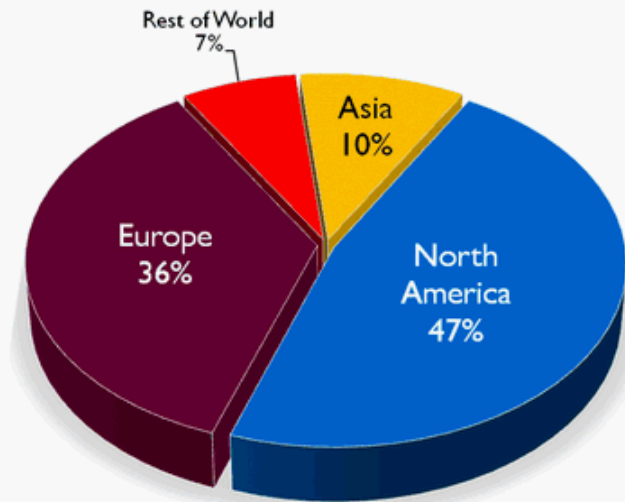

Global Sales Footprint



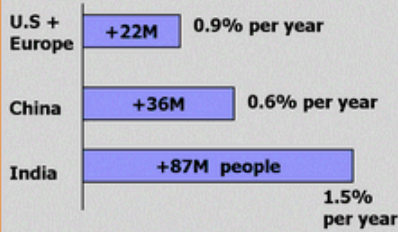

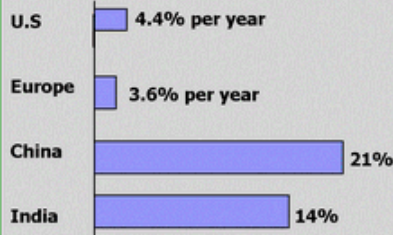
